4. Pre-bid meeting shall be held at **Malangwa Municipality Office, Malangwa, Sarlahi** at **26<sup>th</sup> May 2026, (2083-02-12)**
5. Electronic bids must be submitted to the office **Malangwa Municipality Office, Malangwa, Sarlahi** through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12 pm on 5<sup>th</sup> June, 2026 (2083-02-22)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 5<sup>th</sup> June, 2026 (2083-02-22)** at the office of **Malangwa Municipality Office, Malangwa, Sarlahi**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **80,000/-**, which shall be valid for 30 days beyond the validity period of the bid (Total 120 days from bid opening date).
